Explanatory Notes on Data Retention

1. The purpose of collecting, processing and using the personal data requested in the membership registration form is, besides for managing the DAAD-Freundeskreis e.V. (DAAD Alumni & Friends), for maintaining contact with members and selectively targeting members in their best interests, in connection with the activities of the association. This purpose is also served by data marked as non-mandatory, which is individual information about, or including, activities of the DAAD Alumni & Friends. For example, this applies when we invite the members of specific target groups to specialist events and when we wish to include the expert opinion of selected members for events and publications.
Furthermore, the retention of data in the database of DAAD Alumni & Friends provides a statistical overview of membership structures.
2. Data in the membership registration form will only be used to fulfill the purposes of DAAD Alumni & Friends, thus serving the interests of members, within the scope outlined under Point 1. You are free to choose whether or not to complete the non-mandatory questionnaire points.
3. Data provided in the membership registration form will, in principle, only be retained in the database of the Alumni and Friends of the DAAD. Only the contact details of former DAAD scholarship holders will be compared with DAAD contact details and updated as necessary in order to be able to contact you in connection with DAAD and DAAD Alumni & Friends activities.
